INDEMNITY AGREEMENT. Further, I hereby agree to indemnify and hold harmless Velocity Plus Baseball, LLC, its governing board, officers, employees, and representatives, including without limitation Flint Wallace, from and against all liability whatsoever for bodily injury, illness or death suffered by Participant or any person, and for damage to Participant's property, whether caused by negligence of Velocity Plus Baseball, L.L.C., its governing board, officers, employees and representatives, including without limitation Flint Wallace, or otherwise, and/or whether caused by the intentional act or omission of Participant or any other person.

I HAVE CAREFULLY READ THIS AGREEMENT AND UNDERSTAND IT TO BE A VOLUNTARY WAIVER AND RELEASE OF ALL CLAIMS AND CAUSES OF ACTION FOR OR RELATED TO BODILY INJURY, DEATH OR DAMAGE SUFFERED BY PARTICIPANT, OR TO PARTICIPANT'S PROPERTY, THAT OCCURS AS A RESULT OF PARTICIPATION IN THE CAMP OR TRAINING OFFERED BY VELOCITY PLUS BASEBALL, LLC, AND THAT THIS AGREEMENT OBLIGATES ME TO INDEMNIFY THE PARTIES NAMED ABOVE FOR ANY LIABILITY FOR BODILY INJURY OR DEATH OF PARTICIPANT OR ANY OTHER PERSON, AND FOR DAMAGE TO PARTICIPANT'S PROPERTY, WHETHER CAUSED BY THE NEGLIGENCE OF VELOCITY PLUS BASEBALL, LLC, BY PARTICIPANT, OR OTHERWISE, OR AS A RESULT OF PARTICIPANT'S OR ANY OTHER PERSON'S INTENTIONAL ACT OR OMISSION.
